Legislative & Regulatory Update



On Capitol Hill, support continues to grow for the **AM For Every Vehicle Act**. Unknown as of this writing is what its best path will be for passage. The **Local Radio Freedom Act** also continues to gain support. The NBA thanks **Congressmen Don Bacon, Mike Flood, & Adrian Smith** and **Senators Deb Fischer & Pete Ricketts** for renewing their support of both initiatives.

In welcome FCC news, the Fifth Circuit released its decision on May 19 unanimously vacating the FCC's order requiring collection of Form 395-B data. Relying directly on the arguments raised in the Texas Association of Broadcasters' briefs, it found that the FCC lacks statutory authority to collect broadcaster race and gender employment data at all, and therefore is not permitted to require broadcasters to submit Form 395-B. The NBA joined 43 of our fellow state broadcasters associations in supporting Texas' effort to seek relief from this proposed filing requirement. In other FCC news, the NBA joined other state broadcast associations in filing joint comments through NASBA in response to Chairman Brendan Carr's "Delete, Delete, Delete" initiative.

Nebraska Legislature Update



A sigh of relief for the NBA and our members accompanied the June 2 Sine Die adjournment of our Nebraska Legislature. Despite a number of different bills that could have impacted different facets of station operations, we emerged without harm. We greatly appreciate Governor Pillen and his staff's recognition that a bill taxing advertising is beyond complicated to pass, let alone administer, and would be incredibly harmful to local broadcasters and the citizens we serve. It was nice to avoid that skirmish in this session. That said, we remain watchful and vigilant as next year's session is already expected to begin with budget shortfalls. As the list of tax-exempt goods and services grows shorter, the target on the backs of those exempt grows larger. The NBA thanks our lobbying team of **Korby Gilbertson** and **Justin Brady** for their continued guidance and work on our behalf.

Approval was given to an updated NBA mission statement.

Starting July 7, KIBM AM (1490) and KIBM FM (97.3) will air live broadcasts of Husker Football, Men’s and Women’s Basketball, Volleyball, Baseball, and “Sports Nightly.” In the event of scheduling conflicts, broadcasts will air on KCRO AM (660). Husker Football programming also will air on KCRO, and Walnut will launch a dedicated Husker Sports stream available on the MyBoomerRadio.com app.

Over 200 students from 15 Omaha metro area high schools attended the annual UNO High School Media Conference on April 11, sponsored by the NBA. In addition to keynote speaker **Holly Rowe** of ESPN, students also heard from KETV's **Samantha Pastorino** and WOWT's **Gina Dvorak** about their roles at their respective local TV stations.

UNK Digital Expressions Media Camp

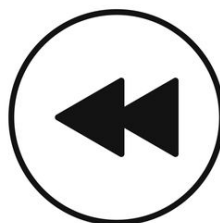

REWIND

1965: 60 Years Ago

Roy Lenwell, KBRL, McCook, has filed for the state legislature. The FCC is cracking down on double billing; this is an illegal and unwise practice. **KOLN TV** and the **Stuart** stations have agreed to underwrite full scholarships to the University of Nebraska Broadcast School.

1975: 50 Years Ago

For the first time, the official State of Nebraska Highway Maps and Tourist Guides list the locations, call letters and frequencies of Nebraska commercial AM and FM radio stations, as a service to the traveling public. Seven hundred thousand copies have been printed for free distribution. The project originated in the NBA Public Relations Committee led by **Ms. Lynne Grasz**, chairperson, and **Max Brown**, director.

1985: 40 Years Ago

On April 14, the Nebraska Legislature gave 28-18 approval to LB 461 authorizing the creation of a statewide public radio network. **Governor Robert Kerrey** signed the bill April 18. This ended the NBA's long, bitter struggle to keep statewide government radio out of Nebraska. According to NBA Executive Director **Ed Schafer**, it was apparent from the outset that the bill could not be killed in committee.

June 29 will be the date of the "Network Switch" for **WOWT** and **KMTV**. KMTV will become a CBS affiliate and **WOWT** will become an NBC affiliate. CBS' contract with WOWT was scheduled to expire in October; NBC's contract with KMTV expires in mid-June. Syndicated shows will not be affected.

1995: 30 Years Ago

John Webster, current President of the Nebraska Broadcasters Association is busy bringing new ideas to the organization. In addition to creating the NBA Foundation, he is hoping to establish a "Pioneers Club", honoring retired broadcasters in the state.

2005: 20 Years Ago

Journal Broadcast Group- Omaha's **KBBX FM**, was awarded a Crystal Award at the NAB 2005 Convention in Las Vegas this past April 19. This is the first time a Crystal has been awarded to a Spanish language station. "**Radio Lobo**" has been serving the Latino community for six years and is the only live and local Spanish outlet for news and information. The station was one of 10 Crystal Award Winners out of 50 finalists.

Upon a request made to the NBA by State Senator **Mike Flood, KUSO**, Norfolk, the NBA has donated audio equipment to the information technology department at the state Capitol in Lincoln, which will allow members of the Unicameral to record news cuts and segments via the internet (mp3) to distribute to stations in their districts.

2015: 10 Years Ago

Radio and TV Journalists who have made notable contributions to Omaha-area journalism were inducted into the Omaha Press Club Journalists of Excellence Hall of Fame on June 6. **Gary Sadlemyer, KFAB** and **Chuck Roberts KMTV/CNN** were inducted in front of a room full of colleagues, family and broadcasting friends. Broadcasters inducted posthumously were **Jack McBride** and **Arnold Peterson**.
